



Thanks so much for your interest in making a positive impact on Piedmont Park! Piedmont Park Conservancy gladly accepts volunteers who are required to complete community service hours and want to help keep Piedmont Park beautiful and safe for future generations.

Court-Ordered Community Service

We do accept court-ordered community service for our Green Market and Green Team opportunities. Our Green Team takes place on select weekdays from 9-11 am. Our seasonal Green Market takes place on Saturdays from 7 am -2 pm. [Learn more.](#)

- **All individuals interested in volunteering with us must be pre-approved by the Conservancy.** Please fill out the Community Service Application/Agreement on page 2.
- Age requirement is 18 and up.
- All volunteers must sign a liability waiver.
- **Accepted court-ordered offenses:** speeding tickets, traffic tickets, and other misdemeanors (at the Conservancy's discretion).
- **NOT accepted court-ordered offenses:** criminal trespass, damage to property, felony offenses, battery, assault, any crime relating to children or abuse, any crime relating to rape or a sexual offense, fraud, theft, shoplifting, disorderly conduct, obstruction of a Law Enforcement Officer, animal cruelty, and violent criminal offenses. The Conservancy reserves the right to add to this list at any time.
- **The Conservancy has the right to dismiss any court-ordered volunteer at any time for any reason.**
- If you are not pre-approved by the Conservancy prior to volunteering, you will not be able to count your hours served toward your court mandated hours.

School Required Community Service

We do accept court-ordered volunteers for our Green Market, Green Team, and select special events. Our Green Team takes place on select weekdays from 9-11 am. Our seasonal Green Market takes place on Saturdays from 7 am -2 pm. Our special events vary throughout the year. [Learn more.](#)

- **Middle School, High School, College/University, or Graduate students do not need to be pre-approved by the Conservancy.**
- **Green Market Age Requirement:** 18 and up
- **Green Team Age Requirement:** 14 and up. Volunteers under the age of 16 must be accompanied by a parent or legal guardian.
- **Special Event Age Requirement:** 16 and up or 18 and up depending upon the event.
- **Minor Requirements:** Minors must present a liability waiver signed by a parent or legal guardian to Conservancy staff when he/she comes to volunteer. Green Team and Special Event volunteers under the age of 16 must be accompanied by a parent or legal guardian.

I will schedule myself ahead of time and keep track of the days I have promised to work.
